## Navy Announces 45-Day Comment Period for PA Memo Supporting Marine Corps Relocation to Guam; Deadline August 25

**ASAN, Guam** – The public is invited to review and submit comments for a Programmatic Agreement memo in support of the Marine Corps relocation to the island; comment period ends August 25, 2023

PA Memos provide an opportunity for interested members of the public to participate in the Section 106 consultation process required under the National Historic Preservation Act (NHPA).

**P-871U Chemical, Biological, Radiological, Nuclear, and High-Yield Explosives (CBRNE) Training Facility supports design efforts including** grading, excavation, filling with borrow and temporary erosion and sediment controls, foundation probing and grouting, paving and site improvements (e.g., asphalt pavement access driveway, sidewalks, facility sign and turf landscaping). Electrical utilities include primary and secondary distribution systems, power, lighting, transformer, and telecommunications infrastructure. Mechanical utilities include condensate French drains and drainage culvert. Subsequent construction is a new single-story CBRNE training complex with a storage facility for the III Marine Expeditionary Force (MEF) at Marine Corps Base Camp Blaz (MCBCB), Finegayan, Guam.

This is a 45-day public comment period and interested members of the community may submit comments via email to <u>criwebcomment@navy.mil</u>.
