Environmental Restoration & Community Outreach

The Department of Defense (DoD) established the Navy's Installation Restoration (IR) Program in 1986 to identify, assess, characterize, and clean up or control contamination from past hazardous wastedisposal operations and hazardous materials spills at U.S. Navy and Marine Corps installations. The program was developed to comply with federal requirements regarding cleanup of hazardous waste sites. These federal requirements are outlined in the Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA) of 1980, as amended in 1986 by the Superfund Amendments and Reauthorization Act (SARA).

In 2000, the National Defense Authorization Act required the DoD to establish a program addressing military munitions, known as the Military Munitions Response Program (MMRP) to address munitions and explosives of concern (MEC) and munitions constituents (MCs) used or released on sites from past operations and activities. The Munitions Response Program (MRP) is the Navy's equivalent to the DoD MMRP. Current IR Program policies and procedures apply to sites under the MRP, as well as provisions for unique explosives safety hazards

The IR Program and MRP at Joint Base Pearl Harbor-Hickam and Pacific Missile Range Facility, Kauai are collectively referred to as the Environmental Restoration (ER) Program. The ER Program is a division of Naval Facilities Engineering Command (NAVFAC) Hawaii's Environmental Business Line.

Process

The Department of the Navy (DON) ER process starts with identification and investigation of contaminated sites, followed by selection, design, and implementation of remedial actions to achieve remediation goals. This process is designed in accordance with CERCLA requirements.

There are two types of DON ER responses:

- **Removal Actions** are taken to address releases or threatened releases requiring prompt action, while Remedial Actions are taken to permanently and significantly reduce the dangers associated with releases or threats of releases of hazardous substances that are serious, but not immediately life threatening. The
- **Remedial Action** process specifies the steps to thoroughly evaluate the nature and extent of contamination, and provides a structure to identify and evaluate cleanup alternatives.

Restoration Advisory Boards (Involving the Community)

The DoD has taken steps to increase public participation in its cleanup program by partnering with the community to form Restoration Advisory Boards (RABs).

The RAB provides a forum for the exchange of information between the Navy and the local community regarding environmental cleanup activities at Joint Base Pearl Harbor-Hickam sites and offers an opportunity for communities to provide input to the cleanup process. They are local boards designed to provide a forum for effective two-way communication work and plans at nearby Navy environmental cleanup sites. The Navy in



Hawaii has three RABs for specific locations: Joint Base Pearl Harbor-Hickam RAB, Lualualei and Waianae Coast RAB, and Central Oahu RAB. RABs meet approximately four times a year (depending on the status of

projects to be presented), and are typically held from 7 p.m. -9 p.m. Locations of meeting are rotated. All meeting are open to the public. Advertisement/notification of RAB meetings is made via public notice in the Star-Advertiser and through email notification to persons who have requested to be on the RAB mailing list.

Other Methods of Informing the Community

- Fact Sheets Federal and state guidelines require ER Program personnel to communicate with community members regarding relevant program activities. Fact sheets are one method of communication that is used during the various stages of the ER Program. These fact sheets will inform interested parties of the progress of the program and of site-specific actions.
- Public Comment Periods A federal requirement of the Remedial Action Process, public comment periods are established at critical times in the cleanup process. All public comments received by the Navy are considered and, as appropriate, incorporated into final documents.
- Public Meetings/Open Houses Community meetings are required to be held at certain key points in the cleanup process in accordance with federal and state requirements. Notices of any upcoming public meetings will be published in the Honolulu Star Advertiser. In an effort to reach affected community members, when appropriate, community meetings will be held in the community closest in proximity to the ER Sites of interest.
