Latte archaeological sites were a major concern for the public based on feedback from the Yigo and Dededo village meetings. Based on this concern, planners sited any proposed new range construction so that no latte sites would be physically or visually impacted by construction. Also, the Almagosa Springs area was eliminated from consideration as a training site due in part to the important Latte archaeological sites and traditional cultural resources located there.

To respond to this concern, visual impacts to that peak are now being addressed through proposed vegetation screening where practical.</p>

NOTICE OF PUBLIC HEARINGS

The Department of the Navy (DoN) and the Joint Guam Program Office (JGPO) will host public hearings on the islands of Guam, Tinian, and Saipan to receive oral and written comments on the Guam and Commonwealth of the Northern Mariana Islands (CNMI) military relocation Draft Environmental Impact Statement/Overseas Environmental Impact Statement (EIS/OEIS). The Draft EIS/OEIS analyzes the potential environmental impacts associated with relocating Marines from Okinawa, Japan to Guam, constructing visiting Aircraft Carrier berthing facilities, and establishing a U.S. Army Air and Missile Defense Task Force on Guam. The Draft EIS/OEIS also examines off base mission critical, mission support, and community support infrastructure improvements needed to ensure that Joint Region Marianas can provide expanded direct support of the DoD strategic mission and operational readiness in the Western Pacific Region. The public hearings will be conducted in accordance with the National Environmental Policy Act and the National Historic Preservation Act.

An open house will take place during the first two hours of each hearing, followed by a two-hour formal public hearing. Informational posters will be displayed and subject matter experts will be available during the open house to discuss the findings of the Draft EIS/OEIS and to answer questions from the public. The formal portion of the hearing will include a presentation followed by a request for comments on the Draft EIS/OEIS. Chamorro translators will be available at all hearings, and Carolinian translators will be available at the Tinian and Saipan hearings.

Oral and/or written comments may be submitted at the public hearings. Oral comments will be limited to three minutes. After three minutes, speakers will be allowed to continue off-stage with a typist. Interested agencies, individuals, and groups unable to attend the public hearings are encouraged to provide written comments postmarked no later than February 17, 2010.
