**Public Comments Accepted Through October 7 for PA Memos
in Support of the Guam Realignment**

PEARL HARBOR-HICKAM – Naval Facilities Engineering Command (NAVFAC) Pacific announced today the start of a 45-day public comment period for new information associated with proposed projects at Naval Base Guam, Telecommunications Site (NBGTS) and Andersen Air Force Base (AAFB), Guam in support of the Marine Corps Realignment.

Comments are being accepted for the Department of Defense’s (DoD) identification and evaluation of historic properties and its determination of effect for J001B: Finegayan Utilities and Site Improvements Phase I (PA Memo #1). Comments are also being accepted for the Department of Defense’s (DoD) plan for resolution of adverse effect for P-240: MWSS Elec Comm & Flightline Armory. The comment period for both projects will remain open through Oct. 7, 2014 (Chamorro Standard Time).

J-001B proposes the first phase of required utilities and site improvements at NBGTS, should NBGTS be the selected alternative for construction of a cantonment area to support the Guam and Commonwealth of Northern Mariana Islands (CNMI) Military Relocation.

P-240 proposes construction of a single story building which will primarily function as a Marine Wing Support Squadron (MWSS) Electronic and Communication Shop and Flightline Armory. The project also includes the construction of equipment wash racks and associated site preparation work within the North Ramp area of AAFB.
