Stipulation VI.A.2: Data Recovery Reports

Stipulation VI.B: Public Education and Interpretation

- No additional educational booklets were produced during the reporting period. Digital copies

- Construction of a memorial monument at the location of burials that were preserved in place was completed at the HR-1 location in J-001B.
- Installation of a marker and artifact display at the location of the Magua site is pending completion of landscaping in the area selected by SHPO.
- Design for an indoor display of archaeological and educational material at the Camp Blaz Visitor Center is proceeding.
- Planning for an outdoor interpretive area at the main entrance to Camp Blaz featuring artifacts and native plants representing life on the Northern Plateau continues; request for funds has been submitted.
- Note that visiting the indoor and outdoor exhibits will not require obtaining base access.

Stipulation VI.D.1: Cultural Resource Awareness

An additional 115 contractors received CR training between Jan 1 and June 30, 2022

Stipulation VI.D.2: Access to Historic Properties on DoD Lands

• Access Plan Coordinator (APC) is working with National Park Service to schedule regular bus tours to Naval Base Guam Munitions Storage Area (NBGMS) sites

- Note that the sites on NBGMS, particularly sites with latte sets, are among the best preserved on the island
- See Sec. VIII for status

Stipulation VI.F: Professional Oversight

- Camp Blaz archaeologists consult regularly with Naval Base Guam and Andersen Air Force
 Base Cultural Resource Managers (CRM) and with the Joint Region Marianas CRM to ensure
 oversight of actions and mitigations related to the Marine Corps Relocation. Camp Blaz
 archaeologists are also in consultation with NAVFAC PAC archaeologists by phone or email
 daily.
- Camp Blaz archaeologists conduct site visits to inspect progress, respond to contractor requests for information and report to the Contract Officer's Representative on any issues.
- Camp Blaz archaeologists communicate with SHPO and the State Archaeologist regarding discoveries and requests for information.
- There are currently two Secretary of the Interior (SOI) qualified archaeologists at Camp Blaz, with efforts to fill a vacant position in progress

Stipulation VI.G: Update of Historic Properties Information

- Contracts for archaeological investigations, whether for surveys or data recovery, require that the contractor prepare a new or updated (as appropriate) Guam Historic Property Inventory (GHPI) form for the property to include a NRHP status recommendation.
- GHPI numbers are issued by SHPO.
- P-608 Survey Report included new and revised site forms for known sites based on survey results
- SHPO has provided GHPI numbers for these sites.

GUAM-SPECIFIC MITIGATIONS (STIPULATION VII)

Stipulation VII.B.1: Signage at South Finegayan

- While Relocation actions (housing) are no longer proposed at South Finegayan, the requirement to update the interpretive sign at the South Finegayan Latte Stone Park remains in the 2011 PA.
- Plans for the interpretive signage and rehabilitation of the area around the latte set including removal of dead trees, grass cutting, etc., have been completed and submitted for approval.
 - The interpretive signage will incorporate information obtained during a 2016 NBG investigation of the features around the standing latte set.
 - o Park boundary will be expanded and delineated by a decorative fence
 - There is also opportunity to manage this requirement with other interpretive needs or initiatives beyond the 2011 PA

Stipulation VII.B.2: Maintain Access to Southern Mountain Trail

There have been no actions restricting access to the Southern Mountain Trail.

Stipulation VII.C.2: Assist SHPO with Update of Guam Comprehensive Preservation Plan

- This requirement occurs at 5-year intervals for the life of the PA.
- 2022 is the next target date for Camp Blaz to assist SHPO with the update of the 2017
 Preservation Plan. The SHPO liaison will play a significant role in this update.

Stipulation VII.C.2: Prepare/Update Stand-alone Guam Synthesis

- The initial Synthesis, published in 2019, consisted of a two-volume set that started after Guam SHPO completed the Historic Preservation Plan in 2017.
- The Synthesis update is funded for 2022 and will provide an opportunity to include new information from military relocation investigations, particularly those on the Northern Plateau.
- Camp Blaz intends to provide a public summary of the updated Synthesis in response to requests from several individuals. This will be posted on the Navy CRI website.

Stipulation VII.C.3: National Register of Historic Places (NRHP) Nominations

This stipulation requires that DoD prepare at least two NRHP nominations per year for historic properties on DoD land.

- Camp Blaz is taking measures to improve the routing systems for nominations for both Navy and Air Force in an effort to speed up the review process.
- Planning for 2022 Nominations is currently in progress (details in table).

nomination for upland agricultural sites, coastal villages and the network of stone lined paths that connect them in the Tarague Embayment. The sites include 66-07-1614, a Latte Period coastal village at Tarague, 66-07-1637, an upland agricultural site, 66-07-1638, a well-preserved section of the network of stone-lined path that connect the agricultural sites with coastal villages and fresh water sources. These sites will be used to develop the context for these and similar sites in the Tarague Embayment. The fourth nomination is a multi-component site near the Known Distance Rifle Range. The site is important for providing early dates that demonstrate pre-latte activities on the Northern Plateau.

Stipulation VII.C.4.a: Cultural Repository Funding

- DON advocated for funding and secured Congressional authorization. Office of Economic Adjustment granted \$12 million to Office of the Governor.
- Construction has been completed on the University of Guam campus
- Tour of the completed facility was offered at Annual Workshop in August 2022
- When the facility is staffed and ready to receive collections, JRM will begin transferring collections to the facility.
- Note that the facility is intended to house all Guam collections, not just JRM.

Stipulation VII.C.4.b: Museum Complex Advocacy

 DON provided a white paper explaining the effort to secure funding and to meet the commitment for advocacy. No federal agency was able to provide funding for a museum complex.

Stipulation VII.D: National Park System on Guam

No impacts to NPS related to the military relocation have been reported.

Stipulation VIII: Tinian Mitigations

• Tinian mitigations stipulated under the 2011 PA remain on hold.

J-008 Finegayan Fire Station

This project consists of two parts: the fire station building and a training area. The fire station is located on Road 10 south of the traffic circle on the main entrance road.

- Note that the project was consulted on in 2011; the station was shown as being south of the baseball field in that consultation
- This is a revision due to changes in APE (separating the fire station from the training area).
- As of this report, alternate locations for the training area are being considered
- Depending on the location selected, additional investigation may be necessary

J-609 Apra Harbor Embarkation Operations Facility

- Project is for vertical construction of a proposed Embarkation Operations Facility for loading and unloading with horizontal installation of associated utilities and infrastructure improvements in the Apra Harbor area at U.S. Naval Base Guam.
 - o 6/11/2020: Design PA Memo was delivered to SHPO
 - 8/30/2022: PA Memo for construction was delivered to SHPO with determination of No Historic Properties Affected.

P-745 Relocation of USF&W Facilities at Ritidian (RC 2022-0283)

In accordance with the 2020 MOA with the Department of Interior, Department of Defense must relocate the existing US F&W facilities at Ritidian to a location within the refuge. In addition, DoD must provide access to recreational areas of Riditian outside the Surface Danger Zone of the firing ranges on the plateau above the beach area

- To comply with the provisions of the MOA, DoD, represented by USMC Camp Blaz, will carry out the requirement to relocate the facilities
- Relocation will use existing roads
- Archaeological investigations will be conducted ahead of construction
- Results of archaeological investigations will provide information for planning construction to avoid or minimize impacts on historic properties
- Consultation with SHPO
 - Camp Blaz EV initiated consultation early in the planning process
 - 1/12/22: Camp Blaz submitted revised draft survey and discovery plan for SHPO review
 - 2/25/22: SHPO provided comments on Draft Archaeological Survey and Discovery Plan (13 pages of comments)
 - Concerns about interagency agreement and ARPA requirements
 - Concerns regarding previous surveys in the area.
 - Requests including Chamorro names for villages

- Requests placing tic marks showing coordinates on edges of satellite imagery
- Comments on methods, details on cultural contexts
- 3/25/22: Meeting between Camp Blaz EV and SHPO
 - SHPO states that USF&W will not sign an ARPA permit without SHPO approval
 - SHPO wants AMDP to include more recent references; Camp Blaz responded that we anticipate a revised work plan
 - State Archaeologist offered to provide a 1954 map showing 20 haligi in the proposed project area (Camp Blaz archaeologists used the map and located remnants of the set)
- o 3/25/22: Camp Blaz submits revised survey and discovery work plan to SHPO
- 4/7/22: SHPO response refers to details in the Archaeological Survey and Discovery Plan (ASDP) that need to be addressed in the fieldwork and reporting; states that SHPO does not approve the ASDP and makes several comments and "requirements"
- o 5/2/22: SHPO provided additional comments on the work plan
 - Commented on document format
 - Commented on fieldwork
 - Commented on items to be included in the technical report (includes several SHPO "requirements")
- 6/15/22: Revised Final Archaeological Survey and Discovery Plan submitted to SHPO
 - 6/27/22: SHPO responds to Camp Blaz response; confirms receipt of ASDP for attending to SHPO recommendations and accept the ASDP and the proposed project.

J-017-V Waterline Interconnect


- July 28, 22: Project for Design Studies for the waterline was delivered to SHPO with finding of No Historic Properties Affected and the comment period ending September 10, 2022
- Subsequently, a conflict with another project was identified, resulting in the need to relocate a section of the waterline
- A Revised PA Memo showing the change will be submitted for review



Section VII. Results of all dispute resolution efforts under Stipulation XIII

J-755 Andy South Construction

- Monitoring continues in road corridors;
- Most current and future effort is completing investigations of HR sites;
- Work in HR-5 resulted in discovery of 14 burials, most in poor state of preservation.

J-001B Utilities and Site Improvements

- Construction of J-001B is nearing completion
- 2/11/22: Construction of the HR-1 monument was completed, with final inspection on 2/11/22

- Archaeological monitoring, required by the 2018 Resolution Agreement, led to discovery of a human tooth with incised pattern indicative of Latte Period practices
 - Investigations led to discovery of seven burial locations, preservation in place and construction of the burial monument at the location
 - Currently, archaeological work consists of investigation of remaining human remains discoveries
 - An archaeological monitor is present to monitor any remaining disturbance.
- A decision is pending regarding disposition of remaining burials in Area D of J-001B for which SHPO has recommended preservation in place

P-715 LFTRC

- Construction completed, final inspection conducted, monitoring concluded
- Draft technical report anticipated

P-735 Multi-Purpose Machine Gun Range

- 2020 Resolution Agreement extended monitoring to P-735
 - 8/30/2021 Camp Blaz notified SHPO of discovery of multiple fragments identified as human remains in a shovel test pit.
 - 5/13/2022 SHPO concurred that there are no grounds for preservation in place of fragmented "possibly human" remains
 - Expect monitoring of those locations that could not be excavated due to MEC presence.
 - Stated that expanded site boundary of 66-08-2856 should have been data recovered to the same extent that newly discovered sites were data recovered
 - 5/18/2022 Delivered EOF to SHPO for SOP investigation of human remains in nonburial context

P-103 Water Well Development (RC 2016-0122)

Vegetation clearing started in April 2022. Archaeological monitoring currently ongoing per 2018 Resolution Agreement.

- Working with National Park Service to facilitate schedule bus tours to the Naval Base Guam Munitions Storage Area

- o Collection and distribution of several species of medicinal plants
- Collection of native seeds and plants

- Collection of lumot
- o APC is working to increase participation in the program

- The position is funded through the Center for Environmental Management on Military Lands (CEMML) at the University of Colorado.
- The Liaison is stationed full-time at SHPO,
- As of 2022, efforts are underway to hire another SOI-qualified liaison through CEMML.

Finegayan Forest Enhancement Sites (RC 2021-0952)

- Project proposes forest enhancement activities within the North Finegayan and Finegayan
 Forest Enhancement Sites (FES). Activities include clearing access paths, removal of invasive
 floral and faunal species, outplanting, and maintenance of outplanting sites.
- The requirement for this action is stated in the 2015 Biological Opinion for the Department of the Navy's Relocation of the U.S. Marine Corps from Okinawa to Guam and Associated Activities on Guam, and subsequent amendments to this document
