SUBJECT: REQUEST FOR REVIEW OF THE FINDING OF NO ADVERSE EFFECTS TO HISTORIC PROPERTIES, NAVAL SPECIAL OPERATIONS TRAINING IN WESTERN WASHINGTON (DAHP Log. No. 2017-05-03022-USN and ACHP Log. No. 0011669)

Dear Mr. Nelson:

In accordance with 36 CFR 800.5(c)(2)(i), the Navy requests review of its finding of No Adverse Effect by the proposed Naval Special Operations Training in Western Washington. There are five conditions to support the finding of No Adverse Effect. The conditions were developed and agreed upon during consultation with the Washington State Historic Preservation Officer (SHPO) and consulting tribes. The SHPO is requesting the agreed upon conditions be stipulated in a two-party memorandum of agreement (MOA) as a prerequisite to her concurrence with the finding of effect. Under the Navy's interpretation of the regulations, the Navy has met all the requirements imposed by 36 CFR 800.5(b) and has no obligation to enter into a MOA stipulating to the five conditions.

As reflected in the enclosed correspondence, after six months of discussions, SHPO failed to formally agree or disagree with the Navy's finding of No Adverse Effect with conditions. As a result, the Navy is proceeding forward by considering SHPO's lack of response as a disagreement with the finding per 36 CFR 800.5(c)(2), and requests ACHP review.

Enclosed is a chronology of our Section 106 consultation (enclosure 1). The Navy began discussing the subject undertaking with SHPO's staff in late 2015 and formally initiated

consultation in April 2017. Enclosure 2 is correspondence evidencing the Section 106 process including letters relating to SHPO's request for a MOA. Although enclosure 2 provides key correspondence between the Navy, SHPO, and ACHP, additional documentation specified in 36 CFR 800.11(e) is available upon In accordance with 36 CFR 800.5(c)(2)(i), this letter and enclosures have been made available to the public via https://navfac.navy.mil/NSOEA

9 Nov 2015 Navy call to Deputy State Historic Preservation Officer to discuss proposed types of training and define which types meet the definition of an undertaking.

Apr 2016-2017 Navy invites SHPO and Department of Archaeology and Historic Preservation staff to attend equipment demonstrations and discuss details of training five times during this period. One meeting was cancelled due to weather. DAHP unable to attend the other offerings.

24 Apr 2017 Navy letters initiating consultation to SHPO, ACHP¹, tribes, and interested parties. The Navy proposes to conduct small-unit land and maritime training activities for naval special operations personnel. 



Thank you for contacting the Washington State Department of Archaeology and Historic Preservation (DAHP) regarding the above referenced proposal. Based upon your letter, we understand that the Navy proposes to conduct small-unit land and maritime training activities for naval special operations personnel. Pursuant to Section 106 of the National Historic Preservation Act of 1966, as amended, and its implementing regulations in 36 CFR Part 800, the Navy is continuing consultation that was initiated on April 24, 2017 (Project Number 2017-05-03022) and asks for your comments on the Navy's proposed definition of the Area of Potential Effects (APE) for the proposed Naval Special Operations Training in Western Washington State (Enclosure 1).

The purpose of the proposed undertaking is to support small-unit training activities of Navy Special Operations personnel in cold-water maritime and land training environments. The intent of the proposed training is to build trainees' skills, experience, and confidence by challenging them in a location with dynamic weather, land, and cold-water conditions. As part of the rigorous training, the trainees learn skills needed to avoid detection along with the goal of leaving no trace of their presence during or after training activities. The locations identified in Enclosure (1) offer optimum training venues because of the diverse representative cold-water maritime environment, land infrastructure, topography, and bathymetry. Additionally, the proximity of several existing Navy installations maximizes logistics, safety, and security.

The undertaking does not include the use of live-fire ammunition, explosive demolitions, manned air operations, off-road driving, vegetation cutting, digging, tree climbing, the building of camp fires, construction, or the building of infrastructure. The transit to training areas depicted in Enclosure (1) is incorporated into the APE and will include public waterways and roads.

Per 36 CFR §800.4(a), the Navy's definition of the APE is based on the scale and scope of the proposed training. The Environmental Assessment that is under preparation for the training identifies three regions in Western Washington State under consideration for the proposed training (Enclosure 1). Each region is defined by the various training options under consideration. For each region, training activities along the shoreline may occur up to 900 feet upland from the shore. In addition, the APE extends out into adjacent water. The APE for the three regions is as follows:

Region 1 (Enclosures 1A-1C): Region 1 extends from Port Townsend in the north to McNeal Island to the south. For clarity, this area has been arbitrarily divided into three areas; northern, central, and southern as follows:







ENCLOSURE 1A: REGION 1 NORTHERN APE

Thank you for contacting the Washington State Historic Preservation Officer (SHPO) and Department of Archaeology and Historic Preservation (DAHP). The above referenced properties have been reviewed on behalf of the SHPO under provisions of Section 106 of the National Historic Preservation Act of 1966 (as amended) and 36 CFR Part 800. Our review is based upon documentation in the Historic Property Inventory (HPI) forms.

As a result of our review, we concur with your determination that the inventoried properties are NOT ELIGIBLE for the National Register of Historic Places under criterion C. Although over 50 years in age, your documentation and photographs indicate that all three properties have undergone extensive alterations/additions within the past 50 years. Our concurrence addresses the following properties only: Seabeck Elementary School (property ID # 679338), the Chambers Creek Maintenance Building (#715923), and the Port of Anacortes Transit Shed (#715950). Although these three resources are not National Register eligible, we look forward to receiving your project determination of effect on other National Register listed and eligible properties in the area of potential effect (APE).

Pursuant to Section 106 of the National Historic Preservation Act of 1966 (as amended) and its implementing regulations 36 CFR 800, the Navy is continuing consultation on the proposed Naval Special Operations Training in Western Washington and asks for your concurrence on the finding of No Historic Properties Adversely Effected. The Washington State Historic Preservation Officer (SHPO) concurred with the Navy's defined Area of Potential Effects (APE) on February 8, 2018 (Log No. 2017-05-03022). Of note, as a result of consultation with tribes, SHPO, and other interested parties, McNeal Island's Area of Potential Effect (APE) has been reduced to include only the immediate area around the old federal prison buildings.

There are a number of activities that may occur singularly or in combination under the proposed Naval Special Operations Training within the APE. The undertaking does not include the use of live-fire ammunition, explosive demolitions, manned air operations, off-road driving, vegetation cutting, digging, tree climbing, the building of camp fires, construction, or the building of infrastructure. A detailed list of training activities, along with description of each activity, are provided in Enclosure 1.

The Navy invited twenty-three (23) Tribes, as identified in its APE letter dated January 22, 2018 (DAHP Log 2017-05-03022), to participate in the consultation process on this undertaking. Tribal outreach was by letters (3), phone calls (3), and emails (3). The comments the Navy received from responding tribes indicated that it was preferred that McNeal Island not be used by Naval Special Operations Training, that any eroding archaeological sites and known

burial sites be avoided, and that the Navy put in place an Inadvertent Discovery Plan to address sites/burials that may be discovered during training activities. A large Traditional Cultural Property (TCP) was identified during consultation with the tribes with the tribes indicating that eroding archaeological sites in this TCP should be avoided. As a result of tribal consultation, proposed training will avoid eroding archaeological sites and known burials, and an Inadvertent Discovery Plan will be implemented if previously unknown archaeological or burials are encountered.

The Navy invited thirty-three (33) interested parties, as identified in its APE letter dated January 22, 2018 (DAHP Log 2017-05-03022), to consult on this undertaking. The Navy did not receive any comments from potentially interested parties in response to these letters.

The Navy held six (6) public meetings to provide an opportunity for the public to learn more about the proposed training and to provide comment on cultural resource concerns. These public meetings were held on:

- May 2, 2017: 5-8pm, at North Kitsap High School in Poulsbo;
- May 3, 2017: 5-8pm at Blue Heron Elementary School in Port Townsend;
- May 4, 2017: 5-8pm at Oak Harbor School District Boardroom in Oak Harbor;
- February 6, 2018: 5-8pm at North Kitsap High School;
- February 7, 2018: 5-8pm at Blue Heron Elementary School; and
- February 8, 2018: 5-8pm at Oak Harbor School District Boardroom.

During the public meetings, the public requested further information on what Section 106 is, and how the Navy is fulfilling the law's requirements. No concerns were expressed specific to historic properties at these meetings. Written comments received following the meetings consisted of one comment claiming that the Navy had not consulted with the Tribes and another concerning the Navy's use of tribal lands. Of note, tribal lands are not part of the Navy's defined APE and are not under consideration for the proposed Navy Special Operations Training.

The Navy has determined that there are recorded historic properties that have been listed in or determined eligible for listing in the National Register of Historic Places (NRHP) within the APE per our proposed inventory methodology dated February 28, 2018 (Enclosure

2). The Navy has applied the criteria of adverse effect per 36 CFR §800.5(2)(1) and determined that Naval Special Operations Training in Western Washington will not adversely affect historic properties.

The proposed Simulated Building Clearance Training Activities is limited to the buildings identified in Enclosure 3. All of these buildings have previously been determined not eligible for inclusion in the National Register of Historic Places (NRHP) with SHPO concurrence. In response to Governor Inslee's request, no Washington State Park's buildings are proposed for Simulated Building Clearance Training Activities.

Archaeological sites determined eligible for listing in or that are listed in the NRHP are found throughout the proposed APE (Enclosure 2). Naval Special Operations Training will avoid eroding archaeological sites and known burials. Prior to training activities, NAVFAC NW cultural resources staff will be consulted to determine whether there may be archaeological sites or burials within the proposed training event area. Training activities will be relocated if sites are known in the proposed training area. Cultural Resources Sensitivity training will be made part of the in-class portion of all training (Enclosure 4). In the event that unknown archaeological sites or burials are encountered during training exercises, training will stop and the enclosed Inadvertent Discovery Plan will be implemented (Enclosure 5).

1 Diver/Swimmer Training Activities

During diver/swimmer training events, trainees swim or dive to an objective area (e.g., harbor, beach, and or moored vessel) for up to six hours. During night training, the trainees would use buoys marked with a glow stick (Chemlight) to identify their location to the support staff. Rubber replica weapons could be carried by trainees to reproduce the bulk and weight of the gear the trainee would carry during an actual mission.

2 Insertion and Extraction Training Activities

During insertion/extraction training events, trainees may approach or depart an objective area using submersible craft, to include UUVs and ROVs, or water crafts (jet skis or small boats). This activity trains personnel to effectively insert and extract people and equipment during the day or night. Submersible and surface crafts would have lighting for night training. Insertion/extraction training events utilizing submersible craft would operate along the shoreline to conduct water-based training.

3 Launch and Recovery Training Activities

During launch and recovery training events, training would be conducted in water areas and consist of launching and recovering submersibles or surface craft, or a combination of both, from a boat ramp, water platform, or via a crane located on a ship or a barge, or Navy pier/wharf.

4 Unmanned Underwater Vehicle Activities

A subset of water-based training would involve the use of a UUV and on occasion an ROV (herein both described as UUVs). A UUV is a batterypowered, unmanned submersible that is hand-launched from a host vessel and would be used to assist with swimmer navigation. The UUVs operate within the water column and would not be set on the floor of the ocean or Puget Sound. UUVs operate under the same navigational rules as any water vessel and would be operated to avoid other vessels. UUVs would be used during approximately 10 percent of the time that other water based training activities would be taking place. The launching and recovery of the UUV would be conducted in water areas only and would utilize a fish finder type of device for navigation. UUVs can be autonomous or tethered and are controlled from the water surface or by a diver for real-time feedback to the operator. Diving personnel may be in the water in the near vicinity of the host vessel for the launch or retrieval portions of the activity. UUVs are tracked by personnel on the host vessel to ensure they remain on course and, if needed, can be recalled any point along the pre-programmed track.

5 Over-The-Beach Training Activities

During an Over-The-Beach training activity, trainees would exit water, cross the beach, and quietly transition to land-based activities. Upon arrival at a pre-designated area, trainees would remain out of sight for several hours before exiting the site or continue moving towards a pre-determined objective. Typically, when trainees conduct Over-The-Beach at a site, they cross the beach twice (arrival and departure). However, when conducing Over-The-Beach training at Naval Base Kitsap Keyport, trainees could move over the beach multiple times. This is a core training competency, as such, trainees are required to conduct this activity until they perform it correctly.

6 Special Reconnaissance Training Activities

Upon arrival at a designated area, trainees would hike to a designated observation point. Trainees are taught the techniques for conducting reconnaissance without alerting anyone to their presence or location. Trainees would remain undetected for a period of time with the goal of leaving no trace of their presence behind. This includes no vegetation being trampled, no branches broken, no footprints visible, or any other indicators that they were there. Trainees would use observation techniques, follow procedures, and report back on a scenario involving role play with military instructors or support staff. Special reconnaissance would be performed on activities that are staged and pre-arranged for training purposes.

7 High-Angle Climbing Training Activities

High-Angle Climbing events are training evolutions where trainees negotiate cliffs, rock faces, and other vertical challenges to develop infiltration and retrieval of climbing equipment techniques. Trainees are instructed in the use of ropes and other climbing gear to traverse obstacles while carrying gear. This training activity will occur in climbing areas designated by Washington State Parks at Deception Pass State Park.

8 Simulated Building Clearance Training Activities

The activity would consist of trainees conducting simulated actions against a site, or a military individual designated as part of the exercise who is simulating a threat or enemy, within a confined area or building. Simulated Building Clearance training develops the trainees' ability to operate within a small unit, move into a structure, conduct clearance from room to room, and engage in role play (military instructors or support staff) simulated combat scenarios. The combat scenarios involve the use of simulated weapons

and simulated munitions from both trainees and support staff acting as enemy opponents. The intent is for trainees to remain concealed and silent, and then departing the area with minimal disturbance and avoiding detection. The training includes the use of weapons configured to only fire plastic or paint pellets. No live-fire weapons or ammunition would be used. The simulated munitions would be marking rounds, which are specialized plastic/paint capsules that are environmentally friendly and water soluble. The temporary marks these simulated munitions make are about the circumference of a dime. Sounds associated with the firing of the simulated munitions sound similar to an air rifle. No property damage would occur, and cleanup (picking up simulated marking rounds/washing away paint marks if present) would be handled by the instructors and support staff immediately at the conclusion of the training scenario. Support staff would be on site at all times in order to ensure the overall safety in the training environment. Simulated Building Clearance sites would typically be separated from the public and would support the appropriate progression of training. These sites would be approved by property owners or land managers. Simulated Building Clearance training would comprise approximately 10 percent of each training block. Buildings identified for this training consist of:

- Building 957: Storage Disposal Facility on Naval Base Kitsap (NBK) Keyport;
- Building 1017: Covered Material Storage on NBK Keyport;
- Building 1018: Truck Loading Platform on NBK Keyport;
- Building 832: Ammunition Wharf on Naval Magazine (NAVMAG) Indian Is.;
- Building 833: Waterfront Operations Building on NAVMAG Indian Is.;
- Building 834: Blockers & Bracers Shop on NAVMAG Indian Is.;
- Building 910: Gasoline Storage Facility on NAVMAG Indian Is.;
- Building 986: Pier Cargo Staging Area on NAVMAG Indian Is.;
- Building 7070: MSF Storage Shed on NBK Bangor;
- Building 7079: Cable Storage Shed on NBK Bangor;
- Warehouse at Chambers Creek Wastewater Treatment Plant;
- Seabeck Elementary School at Seabeck; and
- Transit Shed at Port Anacortes.

9 Unmanned Aircraft Systems Training Activities

UAS would be utilized 10 percent of the time concurrent with other water-based or land-based training activities. The UAS consists of a hand-launched or catapult system, a control system, and a remotely

piloted or self-piloted (i.e., preprogrammed flight pattern) air vehicle that may be fixed-wing or rotary-wing. They would carry only non-hazardous payloads such as cameras, sensors, and communications equipment.

Propulsion is through electrical motor-driven propellers powered by rechargeable batteries. UASs are allowed in FAA designated restricted airspace (R6701). For training outside of R6701, the UAS would be flown at military installations in accordance with a valid FAA Certificate of Authorization. UAS training may be a standalone activity or used in conjunction with other training activities. UAS utilized for the proposed training would:

- be categorized as FAA Group 1 or Group 2 systems, weighing up to 55 pounds,
- vary in size up to approximately two meters in length, with a wingspan of three meters,
- operate below 2,000 feet above ground level,
- would utilize on the ground observers (no manned aircraft observers), and
- fly in accordance with FAA authorizations.

NAVAL SPECIAL OPERATIONS TRAINNING IN WESTERN WASHIGTON INADVERTENT DISCOVERY OF POTENTIALLY ELIGIBLE CULTURAL RESOURCES AND HUMAN REMAINS

In the event of an inadvertent discovery of potentially National Register of Historic Properties (NRHP) eligible cultural resources or Native American human remains during training exercises, training will be re-directed to avoid the discovery. The Navy's on-site Safety Supervisor will ensure that the discovery area is secured in such a way as to prevent trainees or other persons from trespassing on, removing, or otherwise disturbing such remains, and will immediately notify the NAVFAC NW cultural resource staff in the event of the discovery. Training at the site will be discontinued until a professional archaeologist can thoroughly document and sample the discovered cultural material, upon receiving property owner's permission if discovery is off military lands, for the purposes of evaluating its significance. If further impacts to the NRHP eligible site cannot be avoided, then NAVFAC NW cultural resources staff will consult with the DAHP, affected Tribes, the property owner, and interested parties regarding the disposition and treatment of the site. NAVFAC NW cultural resource staff will coordinate the final disposition of the discovery, and training will not resume on that location until NAVFAC NW cultural resources staff have determined that compliance with federal laws is complete.

In the event that human remains are inadvertently discovered, the Navy on-site Safety Supervisor will immediately redirect training to another location. The discovery area shall be secured from further disturbance and the remains shielded from public view. The on-site Safety Supervisor will immediately notify local law enforcement professionals and NAVFAC NW cultural resources staff of the discovery. Law enforcement officials will determine if the remains represent those of a crime scene. Training will not continue until the crime scene investigation is complete and officials approve the resumption of

training activities. If the discovery is determined not to be a crime scene, Navy cultural resources staff will immediately contact the DAHP, the affected Tribes, Agency Official, and the appropriate property owner pursuant to the Native Graves Protection and Repatriation Act (NAGPRA; 45 CFR 10.3). No remains will be removed from their place of discovery until appropriate disposition and treatment procedures are developed in consultation with all concerned parties pursuant to the NAGPRA and OPNAV 11170.2A. Throughout the process, the remains will be treated with care and respect at all times, and will not be photographed. Training may resume at this location 30 days from the date that the Navy agency official was contacted, and only after compliance with all federal laws is complete. If the human remains are to remain on site, the site will no longer be available for future training exercises.

Thank you for contacting the State Historic Preservation Officer (SHPO) and Department of Archaeology and Historic Preservation (DAHP) regarding the above referenced proposal. This action has been reviewed on behalf of the SHPO under provisions of Section 106 of the National Historic Preservation Act of 1966 (as amended) and 36 CFR Part 800. Our review is based upon documentation contained in your communication.

In response, at this time we are not able to concur with your determination that No Historic Properties will be Adversely Effected by the proposed Naval Special Operations Training in Western Washington and instead request additional information about the training program. The additional information is requested in order to address the following concerns and comments:

- In order to address our concerns that archaeological sites in the proposal's area of
 potential effect (APE) have been identified and will be avoided, please provide maps of
 the proposed training areas so that DAHP can research known archaeological sites
 within or in proximity to these areas where the training will be conducted.
- 2) Your letter states that "Naval Special Training will avoid eroding archaeological sites and known burials." There is concern about possible affects from training exercises to other archaeological resources. Therefore, please provide us with protocols for avoidance of damaging all cultural resource types during training activities.
- 3) Your letter states that "Prior to training activities, NAVFAC NW cultural resources staff will be consulted to determine whether there may be archaeological sites or burials within the proposed training event area." Please provide the SHPO with documentation that the "NAVFAC NW cultural resources staff" making these determinations are qualified professional archaeologists.

- 4) Your letter also states that "Cultural Resources Sensitivity Training will be made part of the in-class portion of all training." Please provide the SHPO with the in-class training material in order for DAHP to review and provide comments.
- 5) Our review of the IDP (Enclosure 5 to your letter of 10/18/18) reveals that the plan does not take into account state law as it applies to non-federal and non-tribal lands (State, local, or private) but only assumes that all inadvertent human skeletal remains will be handled under the Native American Graves Protection and Repatriation Act (NAGPRA). Therefore, the IDP should be revised to address human skeletal remains found on non-federal and non-reservation lands following the process outlined in RCWs 68.50.644, 68.60.055, and 27.44.055. Also, State law requires notification to the respective county coroner/medical examiner. Our recommended language for the IDP for finds on non-federal and non-reservation lands in Washington state can be found on our website at the following link: https://dahp.wa.gov/archaeology/human-remains/recommended-inadvertent-human-remains-discovery-language. Once the IDP is revised according to our recommendations, please re-submit to the SHPO for review.

Finally, please note that in order to streamline our responses, DAHP requires that Resource documentation (HPI, Archaeology sites, TCP) and reports be submitted electronically. Thank you for your letter dated November 20, 2018 requesting further information on Naval Special Operations Training in Western Washington. The Navy is continuing consultation on the proposed training and requests your concurrence on the finding of No Historic Properties Adversely Effected. Per your request for additional information about the training program, we offer the following for your consideration.

- 1) You requested maps of the proposed training areas to research known archaeological sites within or in proximity to the areas where training will be conducted. Enclosure 1 provides maps of proposed training areas with sites indicated. If you require further clarification, please refer to DAHP Project No.: 2017-05-03022 in WISAARD. This illustrates the APE as concurred on by the Washington State Historic Preservation Officer (SHPO) (February 8, 2018) along with a tabulation of sites that fall within the APE.
- 2) You requested protocols for avoidance of damaging all cultural resources types during training activities. The Navy determined that the only training activities that have the potential to affect historic properties are the Simulated Building Clearance Training Activities, Special Reconnaissance Training Activities, and Over-The-Beach Training Activities as discussed with the Deputy SHPO during a telephone conversation of November 9, 2015. Since that conversation, High-Angle

Climbing Training Activities was added to the list of training activities. A description of each type of training activity that has the potential to affect historic properties follows.

- a) Simulated Building Clearance Training Activities will only occur in the buildings identified in Enclosure 3 of the Navy's October 18, 2018 Finding of Effects letter. All of these buildings were previously determined not eligible for listing in the National Register of Historic Places (NRHP) with SHPO concurrence (July 5, 2018).
- b) High-Angle Climbing Training Activities will only occur at designated climbing areas within Deception Pass State Park. This is an established climbing area designated by Washington State Parks and existing climbing aids will be used. There are no known historic properties associated with this climbing area. In the event that unknown historic properties are encountered during training exercises, training will stop and the enclosed Inadvertent Discovery Plan (IDP) will be implemented (Enclosure 3). Training activities within state parks are authorized under state park issued use permits.
- c) Special Reconnaissance Training Activities, and Over-The-Beach Training Activities have the potential to effect eroding archaeological sites and burials. Based on pre-training exercise review by NAVFAC NW Secretary of the Interior qualified archaeologists, any known archaeological sites and burials will be avoided. In the event that unknown archaeological sites or burials are encountered during the training exercises, training will stop and the enclosed IDP will be implemented (Enclosure 3).
- 3) You requested documentation that the NAVFAC NW cultural resources staff making determinations of archaeological sites are qualified professional archaeologists. The cultural resources staff that meet the Secretary of the Interior's qualifications as archaeologists will review proposed training activities to assist in avoiding archaeological sites. At present, NAVFAC NW archaeologists that may perform this task include: Kendall Campbell (for NASWI managed properties), David Grant, and Susan Hughes, PhD.

- 4) At your request, the in-class training material that will be used for "Cultural Resources Sensitivity Training" is included as Enclosure 2 of this letter. The material was also provided as Enclosure 4 of the Navy's Finding of Effect letter dated October 18, 2018.
- 5) Upon your recommendation to revise the Inadvertent Discovery Plan (IDP) to address human skeletal remains found on non-federal and non-reservation lands following the process outlined in RCWs 68.50.644, 68.60.055, and 27.44.055, as well as the state requirement to notify the respective county coroner/medical examiner, the IDP has been amended to address these concerns (see Enclosure 3).

Thank you for your letter of December 19, 2018 to the Washington State Historic Preservation Officer (SHPO). Your letter is in response to the Department of Archaeology and Historic Preservation (DAHP) communication of November 20, 2018 with questions and request for additional information about potential effects on historic properties of the Navy Special Operations Training (Navy SEALS) at selected shoreline locations in the Puget Sound basin.

In response, our opinion is that the information provided in your letter in paragraphs 1 through 5 answers our questions and responds to our concerns and recommendations. However, before concurring with your "no adverse effect" on historic properties determination for the training operation, we request execution of a programmatic agreement (PA) with the SHPO regarding implementation of the training activities and the review and clearance of proposed training areas to avoid archaeological resources. The PA should be a concise document that includes the following elements:

- 1) Definition of the Navy SEALS training activities covered in the PA (reference paragraphs 2 (a)-(c) in your letter of 12/19/18). Note: in regard to 2(a) (Simulated Building Clearance Training Activities) we understand that all of the buildings identified as being used for this training activity have been determined not eligible for listing in the National Register of Historic Places. However, we recommend that the PA includes a process for notification, review, and evaluation of buildings, structures, sites, objects, districts, and landscapes that may be added as the training program is implemented.
- 2) States that qualified cultural professionals meeting Secretary of the Interior's Professional Qualifications standards will review all proposed training activities and areas in order to avoid affecting archaeological sites.
- 3) Details a process for notifying the SHPO when the review and clearance of training activity areas takes place by qualified professionals and the results of the review.

Thank you for your letter dated January 15, 2019 providing conditional concurrence with the Navy's determination that no historic properties will be adversely affected by proposed Naval Special Operations Training in Western Washington. This letter provides additional discussion of the undertaking to address the three elements discussed in your letter and further clarification of the proposed undertaking. In summary, the Navy has applied the criteria of adverse effect, considered reasonably foreseeable effects, and found that the undertaking as defined fully qualifies for a determination of no adverse effect with conditions, consistent with 36 CFR 800.5(b), and does not require a programmatic agreement (PA).

Your letter dated January 15, 2019 identifies three elements warranting further discussion. Although a PA is not required, we have addressed the three elements from your January 15, 2019 letter as follows. The first pertains to the possibility that additional historic properties may be added to the training program. The training is strictly constrained to only the undertaking that the Navy has proposed. The Navy recognizes and agrees that if the area of potential effect (APE) changes, additional consultation will be necessary per 36 CFR 800.5(d)(1). Similarly, the Navy remains cognizant of the possibility that new information could introduce new historic properties into the APE or could become available about recorded historic properties, and we remain committed to addressing this

information consistent with our standing responsibilities under the statute and regulations. In order to ensure the Navy has the most current information, the Navy commits to conducting a historic property review of all candidate properties at the pursuit and renewal of the real estate agreements required for access to non-Navy land such as state, county, or municipal parks and private properties. These agreements typically cover a period of five years, and each renewal will include a historic property review. The specifics of this review will also address the second element of your letter and are provided below.

The second element requests the Navy's commitment that the undertaking will be reviewed by qualified professionals. Navy Region Northwest employs several qualified professional archaeologists, who have worked with your office for many years. The Navy continually ensures that all Navy Region Northwest undertakings, including actions associated with the subject undertaking, are reviewed by qualified professionals. Specifically, for this undertaking, a Secretary-of-Interior qualified archaeologist will review the archaeological database of the Washington Information System for Architectural and Archaeological Records Data (WISAARD) for the presence of recorded archaeological sites in or near properties that are subject of proposed or renewed real estate agreements. If identified, the archaeologist will review the site form to determine if the site could reasonably be adversely affected by the training. The proposed Navy undertaking involves trainees learning the skills needed to avoid detection along with the goal of leaving no trace of their presence during or after training activities. This requires creating no trails and avoiding all incidental surface disturbance. For example, trainees would need to avoid an eroding bank, because it would leave physical evidence of the training activity. As a result, leaving archaeological sites undisturbed is in alignment with the proposed undertaking.

The third element in your letter requests a process by which your office will be notified of the review and clearance of training areas, for purposes of historic preservation. In light of operational security requirements and related concerns about sensitive information such as confidential property owner participation, the Navy is confident it can work with you and your staff to develop appropriate means to convey the results of its professional oversight of the undertaking.

Notably, 36 CFR 800.5(b) defines the basis of a finding of no adverse effects with conditions. The Navy recognizes and commits to the following conditions: 1) reopening consultation per 36 CFR 800.5(d)(1) if necessitated by a change in the undertaking; 2) qualified review of new and renewed real estate agreements for new information such as the presence of eroding archaeological deposits or features; 3) implementation of the Inadvertent Discovery Plan; 4) providing sensitivity training; and 5) periodically confirming to your staff adverse effects are being avoided.

The Navy has consulted to define the APE and to consider all historic properties potentially affected. Based on feedback received in consultation, we have refined the undertaking so as to avoid effects to known historic properties. We are committed to ensuring that any post-review discoveries are addressed in compliance with 36 CFR 800.13.

Again thank you and your staff for your thorough consideration. The Navy requests your concurrence with our determination that no historic properties will be adversely affected by the Naval Special Operations Training in Western Washington. As a result of our review, we acknowledge and concur with the five conditions described on page 3 of your letter. However, we request that these conditions be incorporated into a brief and succinct memorandum of agreement (MOA) to be executed by the SHPO and the Navy to ensure that these precautionary steps are taken if and when needed over the timespan of the training programs. - 5. Submittal of an annual report to the SHPO confirming that adverse effects by the program are being avoided.

As noted in prior correspondence, the Navy is committed to the mutually agreed measures, identified in our February 26, 2019 letter, in order to ensure no historic properties are adversely affected. Commitments are as follows: 1) reopen consultation per 36 CFR 800.5(d) if necessitated by a change in the undertaking; 2) ensure qualified review of new and renewed real estate agreements for new information such as the presence of eroding archaeological deposits or features; 3) implement the Inadvertent Discovery Plan; 4) provide sensitivity training; and 5) periodically confirm to your staff that adverse effects are being avoided.

Consistent with 36 CFR 800, the Navy has made a reasonable and good faith effort to identify historic properties, applied the criteria of adverse effect including consideration of reasonably foreseeable effects, and made its finding of no adverse effect with conditions imposed that are fully consistent with the requirements of 36 CFR 800.5(b). An additional agreement document is not required, because 36 CFR 800.5(d)(1) requires the agency to implement the undertaking in accordance with the documented finding.

In accordance with 36 CFR 800.5(c), the Navy requests your written agreement or disagreement with our finding of no adverse effect for the subject undertaking as defined.
